### Rate Sheet

#### **HOURLY RATES**

**Principal**---- at the fixed rate of One Hundred Forty dollars (\$140.00) per hour.

**Associate**---- at the fixed rate of One Hundred Ten dollars (\$110.00) per hour.

**Project Manager**---- at the fixed rate of Ninety dollars (\$90.00) per hour.

**Architect**---- at the fixed rate of Ninety-Five dollars (\$95.00) per hour.

**Engineer**---- at the fixed rate of Ninety dollars (\$90.00) per hour.

**Intern Arch. (Intern 1)**---- at the fixed rate of Seventy-Five dollars (\$75.00) per hour.

**Intern Arch. (Intern 2)**---- at the fixed rate of Seventy dollars (\$70.00) per hour.

**Intern Arch. (Intern 3)**---- at the fixed rate of Sixty-Five dollars (\$65.00) per hour.

**Interior Designer**---- at the fixed rate of Seventy dollars (\$70.00) per hour.

**Technician (Tech 1)**---- at the fixed rate of Seventy-Five dollars (\$75.00) per hour.

**Technician (Tech 2)**---- at the fixed rate of Sixty-Five dollars (\$65.00) per hour.

**Technician (Tech 3)**---- at the fixed rate of Fifty-Five dollars (\$55.00) per hour.

**Administrative and Clerical**----at the fixed rate of Fifty-Five dollars (\$55.00) per hour.

#### **TRAVEL RATES**

For travel that requires more than a normal 8-hour day, our rates are by the day. For travel that can be confined to one day, (typical work day) our rates are based on the listed hourly rates.

#### **REIMBURSABLE EXPENSES**

Expenses related to the execution of work will be billed at 1.15 times the cost to the Architect.

Reimbursables supplied by vendors or outside agents:

- expense of transportation and living expenses in connection with out-of-town travel authorized by the Owner;
- long-distance communications;
- fees paid for securing approval of authorities having jurisdiction over the Project, such as applications, permits, fees, etc.;
- reproductions by a Vendor
- postage, shipping, and handling of correspondence, documents, etc.;

Reimbursable charges for items generated by our office:

- large format plotting (for plans) is billed at \$0.15 per square foot;
- mileage by automobile will be charged at \$0.44 per mile;
- photocopy will be charged at
  - o \$0.10 per sheet for 8-1/2 x 11
  - o \$0.15 per sheet for 11 x 17
